Besides that, an autonomous data growth has arisen at Nh1816 Verzekeringen, of which the volume of the files also substantially increased. Additionally, Nh1816 Verzekeringen wants to have control over the files by knowing where they are located and how they are shared.

Also, the laws and regulations are changing within the financial sector. The Dutch Authority of Financial Markets (AFM) is supervising and needs to know how data is handled.
